Participation:	<p>As parents, you will be notified via email concerning any co-curricular and experiential learning in which your child may participate prior to the event taking place. A special permission form will still be sent home for activities that are held over-night or outside of the Jakarta area. We will also provide information when games or events will take place during school hours.</p> <p>Please be advised that your child is expected to participate in all the activities when they attend these trips and activities, as we are unable to make alternative arrangements to care for a child who is not part of the group, except in cases of medical emergency.</p>
Medical Consent: ** Consent by signature below	<p>As parent or legal guardian of the student named above, I hereby give permission for GJIS teachers accompanying this trip to act in “loco parentis” in the event that we are not contactable during a medical emergency which requires an appropriate adult to make a decision for the well-being of my child. All efforts will be made to establish communications with us using the contact details provided above. GJIS also provides an Emergency Contact Person and driver for all Varsity sporting games, the responsibility of the ECP will be to contact parents and accompany the injured student to a specifically defined JAAC hospital.</p>
Trip Management: ** Consent by signature below	<p>This trip will be led by designated GJIS teachers who are responsible for the students during non-technical activity / pastoral time. All technical activities will be led by designated service providers who will be responsible for student safety during these activities. In acknowledgement of this, all students, parents and accompanying adults must agree to work with any and all instructions from the Trip Leaders relating to trip safety and logistics at all times.</p> <p>*At no time will you be asked to pay up-front for emergency treatment for your child. Should you receive such a request, please contact the Community Liaison Manager, Ibu Anna, ext 217 and inform her.</p>

Acknowledgement of Risk:	<p>GJIS has taken and will take all reasonable steps to ensure the safety of your child whilst he/she is on these trips. However, inherent risks remain which are integral to the activities and the learning experiences being provided; these cannot be eliminated entirely. There is also an inherent risk that, through circumstances beyond our control, conditions may alter which change the anticipated risk levels. We therefore reserve the right to change, delay or cancel certain activities based on our risk assessment at the time. While the risk of serious injury is extremely remote and we will, at all times, use our training and experience to minimize this risk to participants, we are now informing students and parents that there are elements to this trip where risk management may be beyond our reasonable control, despite our best practices.</p> <p>GJIS has Public Liability Insurance in the event of an accident caused by proven negligence on the part one of its employees or contractors.</p>
Personal Belongings:	<p>We do not accept responsibility for loss of or damage to personal property while on these trips. Parents are advised that students should not bring high value electronic devices on these trips as we cannot guarantee that these items can be secured during activities.</p>
Parent/Guardian Acceptance of Risk: ** Acknowledgement by signature below	<p>I, the parent of the student named above, am aware that there are inherent risks that cannot be completely eliminated by GJIS and third-party service providers. I understand that, during my child's participation, he/she will be exposed to above-normal risks as part of the learning experience. I understand that while GJIS will take all reasonable precautions it is impossible to guarantee absolute safety. I understand that I am responsible for ensuring that my child is adequately covered in terms of medical, personal accident and personal belongings insurance and that I am responsible for reimbursing GJIS for any medical or other expenses disbursed on my child's behalf relating to this trip.
